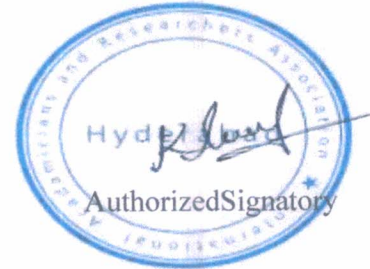

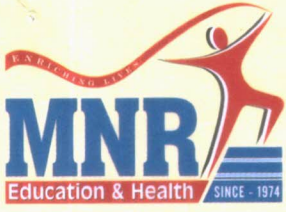

- d) To jointly organise student and faculty development programmes, workshops/  
Seminars etc.,

The terms of Collaboration for each specific activity shall be mutually discussed and implemented, agreed upon in writing both parties prior to the initiation of that activity. Each institution shall designate a liaison officer to develop and coordinate to specific activities and program agreed upon
