

**CONSTITUTION AND
MINUTES OF ANTI-
RAGGING COMMITTEE**



Anti-Ragging Policy

The Anti-Ragging Committee will serve as the governing and advising body for maintaining a ragging-free culture on the college campus. The following are this committee's primary goals:

- ❖ To educate pupils about the perverse nature of ragging and the inherent dehumanising effect it has.
- ❖ To maintain a constant watch and vigil over ragging in order to stop its occurrence and repetition.
- ❖ To respond to reported ragging instances as soon as possible and strictly.
- ❖ To instill a culture of discipline by making it very obvious that no act of ragging will be overlooked and will result in unjust punishment.

Roles and Responsibilities

- To enforce the Supreme Court's directives and follow them, as well as to watch out for any behavior that would constitute ragging.
- To inform all students of current rules and the sanctions that can be applied to individuals who engage in ragging.
- To take into account the student complaints that was submitted, to look into them, to compile a report with suggested sanctions for offenders, and to present it to the Anti-Ragging Committee.
- Keep an eye on how the students' commitments are being obtained in compliance with the rules.
- Hold workshops to educate students about the threat of ragging.
- To give students the names, addresses, and phone numbers of the person or people designated to accept complaints or distress calls; To provide counselling services and raise awareness among the students; To take all required measures.

Ragging constitutes one or more of any of the following acts as per the AICTE/UGC act:

- Every student, in order to be admitted to the institution, must present a character certificate from the institution.
- The results of his or her qualifying examination, which would have addressed the state of his or her behavioural pattern, particularly in terms of whether they had consistently engaged in violent or aggressive behaviour or had any intent to hurt others.
- Any conduct by any student(s), whether by words spoken or written or by any act, which has the effect of taunting, treating, or handling with rudeness a fresher or any other student.
- Such a self-undertaking shall be provided in English as well as in vernacular (Mother tongue of the parent) at the beginning of each academic year by year student.

- Each student, whether a freshman or a senior, must sign an annual self-undertaking with his or her parent(s) that each of them has read the pertinent instruction/regulation against ragging as well as penalties and that the ward be preceded against if found guilty.
- Engaging in boisterous or unruly behaviour by a student or students that annoys, inconveniences, causes physical or psychological harm, or that produces fear or apprehension in any freshmen or other student.
- Asking a student to perform an act that they would not normally perform and that has the potential to negatively impact their physical or mental health, as well as their other students' physical and mental health.
- Any behaviour by a senior student that inhibits, impedes, or otherwise upsets another student's or a new student's routine academic activity.
- Using a fresher or another student's assistance for academic assignments that were given to a person or a group of pupils.
- Any act of financial extortion or coercive financial burden imposed by students on a freshman or any other student.
- The institution must submit the information report to the local police authorities if the parents of a ragging victim are dissatisfied with the action taken by the institution's head.
- To ensure a "Ragging-free Environment" on campus, the institution is empowered to reprimand the offending student and take appropriate measures.
- Any form of physical abuse, including all variations such as sexual abuse, homophobic attack, stripping, requiring vulgar or obscene behaviours, or endangering someone's health or safety.
- Any act of verbal or written abuse, as well as public insults; this includes anything that causes a freshman or another student to feel uncomfortable, whether it be through active or passive participation.
- The aggrieved students are free to report any incidents of ragging to any members of the ragging Anti Ragging Committee by written communication, telephone, or SMS. All efforts will be made to keep the name of the reporting student confidential.
- Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing of power, authority, or superiority by a student over any fresher or any other student.
- After admission, students will get the names and contact information for the committee members.

Punishments:

For those who found guilty of ragging at the Institution level, the following punishments are conceivable under AICTE/UGC section 9 depending on the type and seriousness of the offence as determined:


- Suspension from attending classes.
- Disqualification from participating in any examination, test, or other evaluation procedure with pending results.
- Being prohibited from representing the organisation at any Youth Festivals, Regional, National, or International competitions.
- Expulsion from the hostel or suspension.
- The withdrawal of admittance.

- A suspension from the institution lasting one to four semesters.
- Expulsion from the school, which results in a ban on enrollment at any other institution.
- A fine of up to Rs. 25,000/-
- **Collective punishment:** The institution must use collective punishment as a deterrent to ensure community pressure on the potential ragger when the individuals committing or aiding the crime of ragging are not identified.
